1. Umpire's mat will be used. The mat and **home plate** will be the area that is considered a strike. If the ball touches any part of the mat or home plate, it will be a strike. A pitch must have a legal arc minimum of 3' from point of release and shall not exceed 10' at its highest point while in the air.
2. Three balls, two strikes. Home team is the first team listed.
3. Teams limited to three home runs per game. Once teams reach this limit, a one-up rule will govern home runs. **Any home run that is hit when a home run is not allowed, will be considered an out.**
4. There is a must slide for all bases except first when there is a close play. (Umpire's discretion)
5. 55 minute time limit or 7 innings, whichever comes first. No new inning may be started after 55 minutes from game time.
6. 10 players play on defense. 15 run mercy rule after five innings.
7. There will be no forfeited games. Teams may play with any number of players. Teams will **NOT** be assessed an automatic out for each player less than nine. Teams must notify umpire and scorekeeper if they are playing the game with the players they have present or forfeiting the game.
8. Teams must have matching shirts with at least a 6" number on the back. Everyone must be in uniform for the start of regular season play. Those not in matching shirts will not be allowed to play. Shirts should be worn on outside of clothing.
9. No foul or abusive language will be tolerated. No fighting will be tolerated. Penalties for each of these violations are spelled out in the "Player Code of Conduct". Team captains are responsible to see that all team players know and adhere to the "Code of Conduct."
10. **Changes (additions, replacements, etc) can be made to rosters through May 30th** . After this date, the roster will be frozen for the rest of the season. Changes must be made on the official roster at the Recreation Office, not at the Ball park. Only players listed on the roster will be allowed to play. All fees must be paid before a player can play. Do not try to play under an assumed name! **Teams** caught trying to cheat in this manner will forfeit the game where they were caught; and will also be suspended for two league games. If caught during tournament, the team will be suspended from the tournament. Women's teams may have up to two (2) high school age girls on the roster.
11. CITY TOURNAMENT will be held at the conclusion of the season.
